<b>(stock exchange) member</b>	a firm of brokers or market makers which may deal in securities on a market on behalf of its clients or itself	<b>członek (giełdy)</b>
<b>(stock market) index</b>	a standard that represents the value of stocks in a market	<b>indeks/wskaźnik giełdowy</b>
<b>(stock)broker</b>	a company or person that provides advice and arranges the sale or purchase of securities	<b>makler, broker</b>
<b>(stockholder's) equity</b>	amount representing the type, class, number, and amount of the shares held by stockholders	<b>kapitał akcyjny</b>
<b>abandonment option</b>	early investment-termination option	<b>prawo wcześniejszego wykupu</b>
<b>abandonment value</b>	the value of an investment if terminated before it is scheduled to end	<b>wartość przedterminowego wykupu</b>
<b>active (fund) management</b>	identifying stocks that may produce better returns instead of relying on automatic adjustments	<b>aktywne zarządzanie funduszami</b>
<b>advisory broker</b>	a company or person providing investment advice and executing trade, with the client's express approval	<b>doradca inwestycyjny</b>
<b>All Ordinaries Index</b>	the index of the most active companies listed on the Australian Stock Exchange	<b>All Ordinaries Index</b>
<b>Alternative Investment Market (AIM)</b>	a sub-market of the London Stock Exchange with more flexible rules, for smaller and growing companies	<b>alternatywny rynek papierów wartościowych</b>
<b>American style</b>	a security giving the holder the right to exercise it at any time before its expiry	<b>typu amerykańskiego</b>

<b>Annual General Meeting (AGM)</b>	a meeting informing of a company's previous and future activities, allowing shareholder involvement in its workings	<b>doroczne walne zebranie</b>
<b>arbitrage</b>	buying securities in one country, currency or market, and selling them in another to capitalize on the price difference	<b>arbitraż</b>
<b>at-best</b>	an instruction to buy or sell securities at the best possible current price in the market	<b>zlecenie po najlepszej cenie</b>
<b>at-or-better</b>	an instruction to only fill a transaction at a specific price or above it	<b>zlecenie po określonej lub lepszej cenie</b>
<b>at-the-money (ATM)</b>	an option with a strike price roughly equivalent to the price of the underlying stock	<b>opcja at-the-money</b>
<b>authorized share capital</b>	the number of stock units that a company can issue as stated in its articles of incorporation	<b>autoryzowany kapitał akcyjny</b>
<b>base currency</b>	the currency of used for measuring the return on an investment	<b>waluta bazowa</b>
<b>basket</b>	a portfolio consisting of shares in more than one company	<b>koszyk</b>
<b>bear</b>	an investor selling securities in hope of buying them back at a lower price, expecting the market to go down	<b>niedźwiedź</b>
<b>bear market</b>	a market in which prices are falling and dealers are more likely to sell than to buy	<b>bessa, rynek niedźwiedzia</b>
<b>best bid</b>	the highest price offered by buyers for a specific tradable instrument	<b>najlepsza oferta kupna</b>
<b>best offer</b>	the lowest price offered by sellers for a specific tradable instrument	<b>najlepsza oferta sprzedaży</b>
